# Lakeshore Homes Association Annual Meeting November 18, 2020

Board President Brian O'Malley welcomed members to the 2020 Annual Meeting, taking place over video conference. He then introduced the board members, Chris Metcalfe - Parks Chair, Jasmin Taylor – Secretary & Neighborhood Preservation Chair, Casey Ramsey - Treasurer, and Linda Heath - Neighbor Network Chair.

Brian then provided a brief introduction to the Association, with LHA being the 2<sup>nd</sup> oldest HOA west of the Mississippi, founded in 1917. Designed by the Olmstead brothers, renowned landscape architects who designed Mountain View Cemetery and Central Park in New York.

Brian continued with a recap of this year's events. Our meetings have been held over zoom for most of the year. The effects of the stay home order include more people on the street, more garbage, and more dogs! We remind you to keep dogs on a leash and pick up after them. We completed another round of pollarding of the Sycamore trees that happens every 5-6 years. We have also addressed the threat of a fire by youngsters during fire season. We voted to amend our election rules and held our first election in 5 years with 8 candidates running for the Board.

President O'Malley introduced the first guest speaker, District 2 Councilmember Nikki Fortunato-Bas. CM Bas expressed that she was happy to join us and that it's great to connect especially during shelter in place. She hopes that everyone is staying healthy and adjusting. CM Bas shared that she has lived in Oakland since 1990 – currently lives on the other side of Mandana, is part of this neighborhood and wants to support us as our councilmember.

Several things she and her office have been working on this year — CM Bas recently met with the Downtown Streets team who employ homeless persons to assist with city clean-up and beautification. She has also been working with the city on solutions to continue enjoyment of the lake while keeping it safe by closing off the surrounding streets and working with vendors that set up around the lake. CM Bas' office has also supported free Covid testing and handing out of PPE.

She continues to work on providing compassionate solutions to homelessness – a new city policy was passed last month. Also working on piloting a new model for co-governing in encampments to provide services for safer and more stable environments. CM Bas secured funding to resurface the tennis courts at 18<sup>th</sup> Street, repair public bathrooms at Lakeview Library, and improve lighting at Splash Pad park. She has been coordinating with public works to power wash and clean up business areas. There has been a recent uptick in crime city wide and CM Bas is working with our neighborhood services coordinator and Grand Lake NCPC to address crime in our area. She stressed that it is important to report all crime to OPD so officers will patril where needed.

#### Q&A

- Can neighbors donate to or support the Downtown Streets effort?

  Downtown Streets told Nikki they need bus passes Nikki will be talking to AC Transit about this but maybe financial contributions can be made.
  - More details about crime in our neighborhood?

Grand Lake NCPC have resource officers that share crime reports for this area. There is a rise in violent crime, mostly in east Oakland. There has also been an uptick in home robbery and car break-ins.

• Will we see more police in the neighborhood?

Not sure how much they are patrolling in Crocker area – a new officer has been assigned to our beat. CM Bas will check to see what presence was historically vs. what it is now. She is on the task force looking at how OPD is allocating their time. Up to 40% of calls OPD receives are related to mental health – looking now at how OPD is being stretched. This won't happen overnight, but the task force is looking at how to refocus OPD on violent and serious crime.

President O'Malley introduced the next speaker for the evening, JP Kouakou-Zebouah, founder of the Safer Crocker Highlands security patrol.

JP would like our community to know about the work of the private patrol service and ask that LHA members consider joining. He has lived in the neighborhood for 12 years and loves it, but he has concerns about crime as many other neighbors do. Five years ago, a family was robbed in their home at gunpoint. JP felt something could be done and worked with five LHA neighbors to form the private patrol service. They have asked LHA neighbors to donate \$30 a month for the service. Two local realtors have made generous donations – Anthony Riggins and Robyn Mohr – JP wanted to thank them both. The company that provides the patrol service is Intervention Group, Inc (IGI). JP shared that about 130 homes participate – less than 14 % of LHA – which covers the cost of 1 officer in a marked vehicle for 6 days per week, 8 hours a day on a rotating basis. The patrol makes a minimum of 3 passes by each home each day and IGI responds to any neighbors that call. If criminal activity is observed, the security officer will call OPD. Neighbors can also request a vacation watch if they will be away from home. JP added that although we live in one of the safest neighborhoods in Oakland, he feels better knowing that we can call the patrol that is dedicated to us as a supplement to OPD

JP stressed that they need more members. The goal when the service started was for a 24/7 patrol, which cannot be done at the current level of participation. JP asks that you consider contributing or attending a board meeting and is certain that with 24/7 patrol service, our level of crime would be greatly reduced. Nearby neighborhoods with patrols show that their crime level has been reduced by 50%. It troubles JP to hear about daytime muggings on Trestle Glen. With just \$10 per month from all LHA members, we could increase the patrol hours to 24/7.

#### Q&A

• I have called the patrol when there were incidents – the response time has been 15-30 minutes. Are there statistics on calls made to IGI?

JP responded that because we don't have 24/7 coverage, we share security patrols with other neighborhoods. If we call them when they are in another neighborhood, response time is longer.

• Are there stats on potential crimes or suspicious persons where the patrol has intervened? JP acknowledged that it is difficult to prove the negative. At night, persons coming thru the neighborhood have been followed at a distance to monitor their activity and ensure they exit the neighborhood.

Brian thanked JP for speaking with us this evening and moved on to the Board Member reports. Chris Metcalfe shared that it's been a wonderful year for the parks as they are getting very well used. Nice to see this happening – we introduced small tot playground at the office that is well visited. She is working to keep the forest feeling and manage fire danger by clearing underbrush in Oak Grove. Warren Hook gets a lot of use – we had problem with trash can there that was constantly overfilled and we had to remove the can. Similar problems with trash at Plum Patch. Chris is looking forward to next year and some rain, though we focus on drought tolerant plants. Parks is always looking for committee members – contact the office if you're interested.

Casey Ramsey is the treasurer and looking forward to 2021. Some changes for next year – dues will be increased by \$9 to \$209. The 2021 budget and reserve study were approved. There is one open project to replace the sewer lateral at the office. Late fees were waived for overdue accounts in 2020 and the 2021 Board will decide if late fees will return next year. We are on track, possibly slightly over, for meeting our 2020 budget.

Linda Heath oversees the fun party events as Neighbor Network chairperson. We had a great 2019 but 2020 was very different. Linda was hosting the many events of 2019 and hopes that we will be able to start up again in 2021.

Jasmin Taylor is the chair of the Neighborhood Preservation committee. We review all projects that members are doing at their homes. There were a lot of projects this year and it's always fun to see what neighbors are taking on.

President O'Malley then shared the LHA 2021 Board election results, which was the most exciting election of the year. The following people have been elected to the 2021 Board:
