LHA Board Minutes September 10, 2025

Open Session

Presentation by the President of Safer Crocker, neighborhood security patrol service funded by voluntary donations. Patrol includes all LHA streets 3-5 times daily with services like vacation watches and escorted home entry. Safer Crocker seeks stronger collaboration with LHA, requesting permission for promotional signs and potential integration into LHA dues at \$8/month/member for 24/7 coverage. Discussion included integrating the service into LHA, the need for open bidding to ensure competitive provider selection, concerns about member pushback due to existing security services, and emphasis on community-wide benefits. Per the CCRs, signs are prohibited except for election signs.

President

JB shared an update on AB130, the new law requiring HOA's to update their fine policies. Our HOA attorney is working on the new policy, which will be posted and shared with members for a minimum of 28 days before the Board votes to approve.

James reported that the Macarthur Flock camera is being replaced, bringing the total back to 8 cameras. Shared camera statistics showing 64,000 unique vehicle sightings and 235 hot list vehicle hits this year. Implementation of a one-way traffic flow on Underhills Road caused confusion and pedestrian safety issues around the school. There are ongoing efforts to address parking issues for disabled residents in the area.
